Tudor Place Manuscript Collection Sarah (Law) Williams Papers MS-11

Introduction

Sarah Virginia (Law) Williams (1837-1912) was the second daughter of George Law, Sr., (1806-1881) and Sarah (Anderson) Law (1810-1883). Her father was a wealthy New York entrepreneur of humble origins who built the New York Eighth and Ninth Avenue surface lines, High Bridge, and extended the New York aqueduct. In 1863 she married Major Laurence Abert Williams (1832-1879), the son of Captain Williams (1801-1846) and America (Peter) Williams (1803-1842), a daughter of Thomas Peter (1769-1834) and Martha (Custis) Peter (1777-1854). The daughter of Sarah (Law) Williams and Major Laurence Abert Williams, Anna Wright Williams (1872-1961), married Armistead Peter, Jr., (1870-1960), in 1894.

These papers include correspondence subject files related to the estates of her father, George Law Sr., and her brother, George Law, Jr., (Birth Date Unknown-1896). The collection also includes diaries, legal documents, bills and receipts, and scrapbook material.

These papers were a part of the estate Armistead Peter placed under the auspices of the Carostead Foundation, Incorporated, in 1966; the name of the foundation was changed to Tudor Place Foundation, Incorporated, in 1987. Use and rights of the papers are controlled by the Foundation. The collection was processed and the register prepared by James Kaser, a project archivist hired through a National Historical Records and Publications grant in 1992. This document was reformatted by Emily Rusch and revised by Tudor Place archivist Wendy Kail in 2020.

General social correspondence and letters upon the death of George Law, Jr. One letter from her cousin Robert Law congratulates Sarah (Law) Williams upon the engagement of her daughter Anna Wright Williams to Armistead Peter, Jr.

Letters of congratulation on the marriage of Anna Wright (Williams) Peter to Armistead Peter, Jr., in 1894 and on the birth of Armistead Peter 3rd in 1896.

Letters of condolence upon the death of Josephine (Law) May Haines from John Stuart and W. E. Wright.

CORRESPONDENCE

Letters of condolence upon the death of George Granville Wright.

Consists of social correspondence including two letters from Reverend Doctor G. H. Houghton.

DIARY

1898

Consists of brief daily entries, most of which were made while Sarah (Law) Williams was in residence in New York City, but also Washington, D. C., and Cambridge, New York. During the year she had daily contact with Armistead Peter, Jr., Anna (Williams) Peter, and the infant Armistead Peter 3rd. George Freeland Peter, who was studying at Union Theological Seminary in New York City, was a frequent guest. A great deal of cabling back and forth to her sister Josephine (Law) May Haines. Entries usually record daily activities and business matters without comment.

DIARY

1899

Very similar to 1898 diary in content. Mention of Britannia (Peter) Kennon's illnesses in February and March.

DIARY

1900

Entries typically include the times Sarah (Law) Williams rose and retired, lists of mail she received and sent, books she read, purchases she made, and visits. Written in New York City, Washington, D. C., and Cambridge, New York.

DIARY

1909

Format identical to earlier diaries. Mentions an extended visit by George Augustine Haines. Includes many entries that list sums of money given to members of the Peter family. Illness in late March and early April was serious enough to prevent Sarah (Law) Williams from making any entries in her diary. Entries in October and November from aboard the private railroad car *Colonial* on a trip across the country to Seattle, Washington, and return.

DIARY

1910

Format identical to earlier diaries. Includes entries made in October and November aboard the private railroad car *Colonial* on a trip across the country to Portland, Oregon, and through California.

DIARY

1911

Format identical to earlier diaries, June through October at Content Farm, Cambridge, New York, and aboard the private railroad car *Colonial* on a trip west to St. Louis and south through Kentucky and Virginia.

DIARY

1912

Format identical to earlier diaries. Entries made in New York City and Washington, D. C. Diary ends June 1, the day of her death.

NOTES

1888-1906

Includes genealogical notes, a copy of America (Peter) Williams' epitaph, and a list noting flowers sent and their costs.
