## Tudor Place Manuscript Collection Dr. Armistead Peter Papers MS-13

### Introduction

Dr. Armistead Peter Peter (1840-1902) was the son of Major George Peter (1779-1861) and his third wife Sarah Freeland Peter (1805-1846). He graduated from National Medical College in 1861. In 1867 he married his cousin, Martha Custis Kennon (1843-1886), the daughter of Britannia (Peter) Kennon (1815-1911). They had five children; their son, Armistead Peter, Jr. (1870-1950), became the third owner of Tudor Place. During their marriage the couple lived first at Tudor Place where the doctor maintained an office, and then at 3044 O Street N.W., in Georgetown, Washington, D.C.

Dr. Armistead Peter's papers include correspondence, subject files, legal documents, financial documents, scrapbook material, and printed material. Of interest are the correspondence files containing letters from his son Armistead Peter, Jr., and daughter-in-law Anna (Williams) Peter (1872-1961), as well as the material concerning the deaths of his brother Walter Gibson Peter (1842-1863) and cousin Williams Orton Williams (1839-1863).

These papers were a part of the estate Armistead Peter placed under the auspices of the Carostead Foundation, Incorporated, in 1966; the name of the foundation was changed to Tudor Place Foundation, Incorporated, in 1987. Use and rights of the paper are controlled by the Foundation. The collection was processed and the register prepared by James Kaser, a project archivist hired through a National Historical Records and Publications grant in 1992. This document was reformatted by Emily Rusch and revised by Tudor Place archivist Wendy Kail in 2020.

### **Biographical Sketch**

Dr. Armistead Peter (1840-1902) was born in Montgomery County, Maryland, on February 23, 1840, the son of Major George Peter (1799-1861) and Major George Peter's third wife, Sarah (Freeland) Peter (1805-1846). His early education was obtained in school and under private tutors. After the death of his mother he lived in Georgetown, where he received guidance and encouragement for a medical career from Dr. Joshua Riley (1800-1875). He studied medicine at the National Medical College of Columbian University [George Washington University], Washington, D.C., graduating in February 1861. He settled in Georgetown and opened a general practice. He was a member of the American Medical Association, of the Medical Association of the District of Columbia, and vice-president of the alumni association of the National Medical College. He published articles in the *American Journal of Medical Science*. He was also a director of the Potomac Fire Insurance Company.

When the Civil War commenced he volunteered as a surgeon to the Confederacy, but was advised more doctors were not needed. Despite his family's southern leaning he offered his services to the Union Army; he served as Acting Assistant Surgeon of the United States Army in service at the Seminary Hospital of the District of Columbia as Ward Surgeon, and was placed in charge of the facility. He was ordered to open a hospital at Water's warehouse in Georgetown, but returned to the Seminary Hospital of his own accord. For several years he was a member of the Georgetown board of health, and was small-pox physician to the poor during 1866.

He married his cousin Martha Custis Kennon on April 23, 1867, and the couple resided at Tudor Place, where five children were born to them: Walter Gibson Peter (1868); Armistead Peter, Jr., (1870); Beverley Kennon Peter (1872); George Freeland Peter (1875); Agnes Norfleet Peter (1880). Their second son, Armistead Peter, Jr., would become the third owner of Tudor Place upon the death of his grandmother, Britannia (Peter) Kennon in 1911. Dr. Armistead Peter maintained an office in the East Wing of the house and saw his patients there. Eventually the couple built their own home in Georgetown on Congress Street between Stoddard and Road Streets [3044 O Street N.W., Georgetown, the corner of 31<sup>st</sup> and O Streets]; they also held property in Montgomery County, Maryland.

Dr. Peter died in 1902.

Also includes one letter from Martha (Williams) Carter asking him to collect information on his trip to Franklin, Tennessee, to retrieve the bodies of her brother William Orton Williams and cousin Walter Gibson Peter. Martha (Williams) Carter's letter also discusses funeral arrangements and Sarah (Law) Williams. A letter from Major Laurence Abert Williams accompanied a check for one hundred dollars, his share of the expenses of retrieving the bodies of his brother William Orton Williams and cousin.

### **CORRESPONDENCE**

1876-1879

Five letters, one from a brother containing family news, several letters concerning medical matters, and one from the editor of the Georgetown *College Journal* thanking him for reminiscences about Major George Peter, his father.

1883-1884

Letters from an ex-Georgetown neighbor, S. H. Hour, Attorney William A. Gordon, and A.S. Abell, editor of the *Baltimore Sun*. Includes an invitation to the reinternment of John Howard Payne at Oak Hill Cemetery.

### **CORRESPONDENCE**

1886-1887

Nine letters expressing condolence upon the death of Martha (Kennon)) Peter, his wife.

#### **CORRESPONDENCE**

1890-1892

Five brief letters dealing with social matters.

### **CORRESPONDENCE**

1893-1894

Seven letters, several from patients and two from friends on long trips, one traveling in western United States after touring the Chicago World's Fair, and another traveling in England. One letter is from a health resort in Colorado and includes brochures describing the resort's services.

### **CORRESPONDENCE**

1895

Three letters from or concerning patients.

### **CORRESPONDENCE**

1896-1897

Includes one letter from his daughter Agnes (Peter) Mott, one from Sarah (Law) Williams, and seven letters from Mary Evon Metzradt, who was Anna (Williams) Peter's nurse, consisting of consultations on the health of Anna (Williams) Peter.

1899-1901

Five letters from families of Dr. Armistead Peter's patients.

### CORRESPONDENCE: MARY S. FERGUSON

1900-1901

Consists of three lengthy letters written from Manila, the Philippines. Apparently Mary S. Ferguson was a friend who had lived in Georgetown and had instructed Dr. Armistead Peter to watch out for her sister, who was not in good health.

### CORRESPONDENCE: ARMISTEAD PETER, JUNIOR

March 1890

One letter written from Old Point Comfort, Virginia, discussing sightseeing trips.

### CORRESPONDENCE: ARMISTEAD PETER, JUNIOR

August-September 1890

Six letters written while Armistead Peter, Jr., was traveling with the Sarah (Law) Williams and her family. During this trip he saw Content Farm,

Cambridge, New York, for the first time and went aboard George Law's yacht.

### CORRESPONDENCE: ARMISTEAD PETER, JUNIOR

October-November 1890

Five letters, three of which deal with arrangements for Armistead Peter, Jr.'s, return to Georgetown after his summer travels and two dealing with a hunting trip in Virginia he made with his friend Frank Beall.

# CORRESPONDENCE: ARMISTEAD PETER, JUNIOR 1891

Includes three letters, two written while visiting the Williams family at the Fifth Avenue Hotel in New York City and in Philadelphia, Pennsylvania. One letter was written while Armistead Peter, Jr., was apparently living at 3044 O Street, Georgetown, and discusses maintenance of the house.

# CORRESPONDENCE: ARMISTEAD PETER, JUNIOR 1892

Four letters, including one written while Armistead Peter, Jr., was living at 3044 O Street, Georgetown, which discusses maintenance of that property and Tudor Place. Three other letters were written from Content Farm, Cambridge, New York, and describe activities there.

Letters from Saratoga Springs, New York, New York City, Cambridge, New York, and Chicago, Illinois.

Consists of four letters written from Content Farm, Cambridge, New York, that discuss social activities and hunting.

### CORRESPONDENCE: ARMISTEAD PETER, JUNIOR

August-September 1894

Four letters, including three written from Content Farm, Cambridge, New York Farm, one of which mentions a visit from Walter Gibson Peter and one letter written after Armistead Peter, Jr.'s, return from a trip to the West.

### CORRESPONDENCE: ARMISTEAD PETER, JUNIOR

January-August 1895

Includes eleven letters. One letter describes an extended visit with Josephine (Law) May Haines. Four letters written on a trip through the West aboard Sarah (Law) Williams' private railroad car. Six letters from Content Farm, Cambridge, New York.

### CORRESPONDENCE: ARMISTEAD PETER, JUNIOR

September-December 1895

Three letters from Content Farm, Cambridge, New York, one of which announces the wedding of Josephine (Law) May Haines to George Augustine Haines. Also includes letters written while on a trip to Atlanta, Georgia, and the Cotton States International Exposition.

### CORRESPONDENCE: ARMISTEAD PETER, JUNIOR

January-March 1896

Four letters, one discussing a planned trip to Georgetown, and another about the advantages of living in the Fifth Avenue Hotel, New York City.

### CORRESPONDENCE: ARMISTEAD PETER, JUNIOR

April-June 1896

Seven letters concerning the activities of Armistead Peter, Jr., his wife and in-laws. Arrangements are made in preparation for his wife's accouchement at Content Farm, Cambridge, New York, where Dr. Armistead Peter will serve as physician.

### CORRESPONDENCE: ARMISTEAD PETER, JUNIOR

July-August 1896

Consists of five letters that discuss activities at Content Farm, Cambridge, New York, and Anna (Williams) Peter's postnatal condition.

### CORRESPONDENCE: ARMISTEAD PETER, JUNIOR

October-December 1896

Three letters describe the good health of Armistead Peter 3rd, activities at Content Farm, Cambridge, New York, baby gifts received, and an impending visit to Washington.

### CORRESPONDENCE: ARMISTEAD PETER, JUNIOR

January 1897

Includes seven letters and two telegrams most of which detail illnesses of Armistead Peter, Jr., and Armistead Peter 3rd. One letter included a newspaper clipping about Alga (Smith) Law, the wife of George Law, Jr. Another letter mentions an unsuccessful attempt to set a date for christening Armistead Peter 3rd.

### CORRESPONDENCE: ARMISTEAD PETER, JUNIOR

February-May 1897

Five letters in which Armistead Peter, Jr., expresses concern over Britannia (Peter) Kennon's illness, announces the date for Armistead Peter 3rd christening, and mentions a visit by his brothers Walter Gibson Peter and Beverley Kennon Peter.

## CORRESPONDENCE: ARMISTEAD PETER, JUNIOR

July 1897

A letter about a coin Robert Peter brought with him when he immigrated from Scotland and servant problems at Content Farm, Cambridge, New York.

### CORRESPONDENCE: ARMISTEAD PETER, JUNIOR

September-October 1897

Letters describe Armistead Peter, Jr.'s, ill health, recount Armistead Peter 3rd's activities, and ask for advice about a health problem of the boy.

### CORRESPONDENCE: ARMISTEAD PETER, JUNIOR

November-December 1897

Consists of four letters discussing plans for trips to Washington, D.C., and New Orleans, Louisiana, attendance at theaters, and visits from George Freeland Peter and Walter Gibson Peter. One letter refers to an illness of Dr. Armistead Peter.

### CORRESPONDENCE: ARMISTEAD PETER, JUNIOR

January-March 1898

Five letters regarding a planned trip to Washington, D.C., to visit the convalescing Dr. Armistead Peter, news of New York City and George Freeland Peter who is in the seminary there, and a hunting trip with George Granville Wright at Porter's Bar, in Maryland.

### CORRESPONDENCE: ARMISTEAD PETER, JUNIOR

May-July 1898

Includes four letters about activities in New York, a visit by George Freeland Peter, mentions of the Spanish-American War, and arrangements for a proposed trip by Dr. Armistead Peter to Content Farm, Cambridge, New York.

### CORRESPONDENCE: ARMISTEAD PETER, JUNIOR

September-December 1898

Nine letters including two written from Content Farm, Cambridge, New York, and seven written from the Fifth Avenue Hotel in New York City. Topics covered: the weather at Content Farm, Cambridge, New York; the servant problems of Dr. Armistead Peter and Anna (Williams) Peter; the health of various family members; a cold suffered by Armistead Peter 3rd.

### CORRESPONDENCE: ARMISTEAD PETER, JUNIOR

January-February 1899

Seven letters mention the health of Armistead Peter 3rd, the death of Dr. Campbell, the activities of George Freeland Peter, and the weather in New York.

# CORRESPONDENCE: ARMISTEAD PETER, JUNIOR April 1899

One letter that discusses the ill-health of Anna (Williams) Peter and Sarah (Law) Williams, and a book entitled *From Reefer to Rear-Admiral: Reminiscences and Journal Jottings of Nearly Half A Century of Naval Life* by Admiral Benjamin F. Sands that mentions Commodore Beverley Kennon.

# CORRESPONDENCE: ARMISTEAD PETER, JUNIOR

June-July 1899

Three letters, one written from the Fifth Avenue Hotel and two from Content Farm, Cambridge, New York, covering the great heat the family is suffering in New York City, the growth of Armistead Peter 3rd, and the death of Josephine (May) Haines.

### CORRESPONDENCE: ARMISTEAD PETER, JUNIOR

September-October 1899

Three letters including one from Content Farm, Cambridge, New York, and two from the Fifth Avenue Hotel. Armistead Peter, Jr., describes activities at the farm, recounts in detail an incident with a burglar in which one of the servants was involved, and discusses arrangements for a trip to Washington.

### CORRESPONDENCE: ARMISTEAD PETER, JUNIOR

December 1899

One letter notes an article that may be written about the Peter family and describes Christmas celebrations.

# CORRESPONDENCE: ARMISTEAD PETER, JUNIOR

Includes nine letters, three written from Content Farm, Cambridge, New York, and the rest written from the Fifth Avenue Hotel, New York City. The letters note: the weather in New York and at the farm; a visit by George Freeland Peter to Content Farm, Cambridge, New York; illness of Kate (Williams) Upshur; gifts sent to Dr. Armistead Peter; and the activities of Armistead Peter 3rd. Notes from Armistead Peter 3rd enclosed.

### CORRESPONDENCE: ARMISTEAD PETER, JUNIOR

January-March 1901

Six letters written from the Fifth Avenue Hotel, New York City, concerning Armistead Peter, Jr.'s, health, George Freeland Peter's health, a visit by Agnes (Peter) Mott, the weaning of Armistead Peter 3<sup>rd</sup>, the illness of a servant, and the preparations for a visit to Washington.

## CORRESPONDENCE: ARMISTEAD PETER, JUNIOR

June-October 1901

Includes three letters from Content Farm, Cambridge, New York, and one from the Fifth Avenue Hotel, New York City, describing the weather, the

outdoor activities of the family, the ill-health of Anna (Law) Wright, and mentions the assassination of President McKinley fulminating against the anarchists. One letter details the death of a servant.

# CORRESPONDENCE: ARMISTEAD PETER, JUNIOR 1902

One letter discusses the health of George Granville Wright and Anna (Law) Wright, and plans for a trip to Washington to celebrate Britannia (Peter) Kennon's birthday.

# CORRESPONDENCE: ANNA (WILLIAMS) PETER 1894

Six letters including five from Content Farm, Cambridge, New York, and one from St. Paul, Minnesota. The letters are formulaic and contain little news and few descriptions; the letter from St. Paul was written during a trip through the West.

# CORRESPONDENCE: ANNA (WILLIAMS) PETER 1895

Includes three letters: one asks Dr. Armistead Peter to send a prescription to cure an illness of Armistead Peter, Jr.; one thanks Dr. Armistead Peter for the prescription, and notes the pharmaceuticals effect. The third letter discusses plans for a trip to Washington.

# CORRESPONDENCE: ANNA (WILLIAMS) PETER 1896

Seven letters referring to birthday gifts sent to Dr. Armistead Peter. Other letters discuss the weather, mention Armistead Peter 3rd, and health matters.

# CORRESPONDENCE: ANNA (WILLIAMS) PETER 1897

Letters which deal with Armistead Peter 3rd's health and baby formula.

# CORRESPONDENCE: ANNA (WILLIAMS) PETER 1898

Four letters report on Armistead Peter 3rd's health, comment on family news, and recount events on Content Farm, Cambridge, New York, and in New York City.

# CORRESPONDENCE: ANNA (WILLIAMS) PETER 1899

Five letters discuss arrangements for visits by Agnes (Peter) Mott and Dr. Armistead Peter and comment on social activities with George Freeland Peter. One letter mentions Armistead 3rd's diet and another refers to the illness of Martha (Williams) Carter.

The letters in 1870 were written while Martha (Kennon) Peter was visiting relatives at Lynwood, Maryland, as well as staying at a boarding house presumably in the mountains to improve the health of Walter Gibson Peter and Britannia (Peter) Kennon. The 1885 letters were written while Dr. Armistead Peter was traveling in Britain and describe the health of various patients and relate the activities of his family. Letters mention major work on the streets near 3044 O Street, Georgetown.
