# Tudor Place Manuscript Collection Augustine Haines Papers MS-15

### Introduction

This correspondence consists of documents and scrapbook material collected by Augustine Haines (1810-1873), the father of George Augustine Haines (1843-1915). The largest part of the collection is the series of letters written by George Augustine Haines to his father while travelling in Europe from 1866 to 1868. Letters written by Samuel Haines II (1780-1825), George Augustine Haines' grandfather, to his father Samuel Haines I (1747-1838) and other members of the Haines family, are scattered between 1809 and 1827. These letters were collected and saved by Augustine Haines from various sources. There is also incoming and outgoing correspondence of Augustine Haines from family members and political associates.

These documents came into the Tudor Place manuscript collection through the estate of George Augustine Haines, who had married Josephine (Law) May Haines (1834-1899), an aunt of Anna (Williams) Peter (1873-1961). This material was shipped from the Villa Maria on Lake Como, Italy, where George Augustine Haines and Josephine (Law) May Haines had established residency. Armistead Peter, Jr. (1870-1960), was responsible for closing the villa and dispersing its contents after the death of George Augustine Haines in 1915. It was found in the garret of Tudor Place in the trunk in which it had been shipped.

These papers were a part of the estate Armistead Peter placed under the auspices of the Carostead Foundation, Incorporated, in 1966; the name of the foundation was changed to Tudor Place Foundation, Incorporated, in 1987. Use and rights of the papers are controlled by the Foundation. The collection was processed and the register prepared by James Kaser in 1991-1992. In 2020 this document was reformatted by Emily Rusch and revised by Tudor Place archivist Wendy Kail.

# **Biographical Sketch**

Augustine Haines (1810-1873), the father of George Augustine Haines (1843-1915), was born in Portland, New Hampshire, March 17, 1810. He read law with Governor Fairchild and was admitted to the bar in York County, New Hampshire, in January 1830. He was the state's attorney for Cumberland County in 1834. He married Frances (Patten) Haines (1816-1894) in 1839 in Portland; the couple had three children: Charles Glidden Haines II in 1840; George Augustine Haines in 1843; and Elisa Frances Haines in 1847. Augustine Haines removed to Portland, Maine, and was appointed United States attorney for the district of Maine in April 1845. He resigned as United States Attorney and by 1848 was employed as an agent for Laconia Mills, a textile mill that produced heavy, denim-like fabrics, in Biddeford, Maine, a position he held until his death in 1873.

Samuel Haines II (1780-1825) was the father of Augustine Haines and the grandfather of George Augustine Haines. He was born at Canterbury, New Hampshire, on May 22/30, 1780. He graduated from Dartmouth College, Hanover, New Hampshire, in 1803. He read law with Fisk and Clegg of New York City, and established a practice in Portsmouth and Sanbornton, New Hampshire, in 1808. He published Independence Day orations in 1808 and 1809. Commissioned a 1st Lieutenant in the 4th Infantry Regiment of the United States Army in 1808, he resigned in 1809, but later served in the War of 1812. He married Elisa (Gookin) Haines (1788-Death Date Unknown) in 1809. He removed to West Florida in 1813, and then to Blakely, Alabama Territory, where he was counsellor of law 1814-1825 and postmaster of Blakely in 1818.. He died in Providence, Rhode Island, on a journey of return to visit his home state.

Little is known of Samuel Haines I (1747-1838), the father of Samuel Haines II, grandfather of Augustine Haines, and great grandfather of George Augustine Haines. He was born in Greenland, New Hampshire, in 1747. He enlisted in Colonel Enoch Poor's 2nd New Hampshire Regiment in the Continentl Army in 1775, and served in the Revolutionary War. He married Hannah (Johnson) Haines (Dates Unknown) of Rowley, Massachusetts on July 9, 1772; the couple had nine children. Samuel Haines I died in 1838 in Canterbury, New Hampshire.
