# **Introduction**

Josephine (Law) May Haines (1834-1899) was the sister of Sarah (Law) Williams (1837-1912), the mother of Anna (Williams) Peter 1872-1961) who married Armistead Peter, Jr. (1870-1960).

Josephine (Law) May Haines was married twice. Her first marriage was in 1853 to Colonel Charles Augustus May (1818-1864), a Mexican War hero who died in 1864.

The Villa Maria on Lake Como, Italy, became Josephine (Law) May's permanent residence in 1894. She married George Augustine Haines (1843-1915) on September 16, 1895. She is important to the history of Tudor Place because the bulk of her substantial estate and many objects from Villa Maria are at Tudor Place. Most of the papers in this collection date from after her move to Italy and primarily concern Villa Maria. These documents came to Tudor Place through Armistead Peter, Jr., who was responsible for closing up Villa Maria after the death of George Augustine Haines, Josephine (Law) May Haines' husband. The papers include social and business correspondence, subject files, legal documents, financial documents, lists and inventories, scrapbook material, and printed material.

These papers were a part of the estate Armistead Peter placed under the auspices of the Carostead Foundation, Incorporated, in 1966; the name of the foundation was changed to Tudor Place Foundation, Incorporated, in 1987. Use and rights of the papers are controlled by the Foundation. The collection was processed and the register prepared by James Kaser, a project archivist hired through a National Historical Records and Publications grant in 1992. This document was reformatted by Emily Rusch and revised by Tudor Place archivist Wendy Kail in 2020.

# **Biographical Sketch**

Little detail is known of the life of Josephine (Law) May Haines (1834-1899), the oldest daughter of the five children of industrialist George Law (1806-1881) and Sarah (Anderson) Law (1810-1883). She was the sister of Sarah (Law) Williams (1837-1912), whose daughter Anna (Williams) Peter (1872-1961) married Armistead Peter, Jr. (1870-1960), third owner of Tudor Place.

Josephine (Law) May Haines was married twice. On February 8, 1853, she married Colonel Charles Augustus May (1818-1864), a Mexican War hero. According to newspaper legend, the couple resided on Fifth Avenue in New York City just below Twenty-ninth Street, where Josephine (Law) May entertained and gave musicals and dinners. Colonel Charles May died in 1864; after his death she became very devout and was one of the first women in New York to have a chapel in her home.

Josephine (Law) May made the Villa Maria, Cadenabbia, on Lake Como, Italy, her permanent residence in 1894. The villa had been built 1889-1892 by the famous architect Giacomo Mantegazza; it was a majestic structure with a double series of arches in the center of the façade; a staircase connected the villa to a park and a wet dock on the lake. Josephine (Law) May Haines married George Augustine Haines (1843-1915) on September 16, 1895. Together the couple renovated their villa, entertained guests, and travelled abroad. Josephine (Law) May Haines died in Basel, Switzerland, on July 5, 1899.

Incoming

Most of these letters date from 1896 through 1898. These include letters from family members George Law, Jr., Alga (Smith) Law, Anna (Law) Wright, Sarah (Law) Williams, but are mostly general social correspondence. A number of letters are from Charles Whitehall, a friend from New York, and Luigi Gulli, who seems to have been an impresario for a musical ensemble that Josephine (Law) May Haines supported. One letter is from Archbishop Corrigan of New York City.

#### **BUSINESS CORRESPONDENCE**

1894-1899

Incoming

Consists of business correspondence, primarily dealing with the renovation and furnishing of the Villa Maria. Several letters are from contractors and subcontractors and from interior decorators and antiques dealers from Paris and London. An exchange of correspondence with Steinway and Sons indicates the type of piano purchased from the firm and its placement at the Villa Maria. Some letters are from clothing designers, including the House of Worth. Other letters relate to financial transactions with Brown and Shipley, the United States Trust Company of New York, and an Italian bank, and a legal case in which John Hardy represented Josephine (Law) May Haines. Many letters have bills/receipts, account statements, or measured drawings attached.

# BUSINESS CORRESPONDENCE: JAMES AFFLECK 1895-1899

James Affleck was the Law family lawyer, but these letters deal mostly with the private financial matters of Josephine (Law) May Haines, including the settlement of her brother George Law, Jr.'s, estate, payment of dividends from the George Law, Sr., estate, the closing of the Law family house at 259 Fifth Avenue, New York City, and the disposal of the furnishings in the house.

# BUSINESS CORRESPONDENCE: J. G. AFFLECK 1896-1899

- J. G. Affleck was James Affleck's nephew. As his uncle's health faltered, J.
- G. Affleck took over his uncle's business.

# BUSINESS CORRESPONDENCE: JOHN M. SCRIBNER

1896-1897

John M. Scribner was George Law, Jr.'s, lawyer and these letters concern the settlement George Law, Jr.'s, estate.

One outgoing letter to Enrico Zanoli placed him in charge of the Villa Maria.

# MONSIGNOR MARTIN CLERC

1884-1902

Josephine (Law) May Haines met Monsignor Martin Clerc in Rome, where he was the Vatican correspondence to *L'Univers*, a Parisian Roman Catholic newspaper. In the winter of 1892 she asked him to serve as her personal chaplain. Monsignor Martin Clerc was well connected in ecclesiastical circles. Included in this subject file are letters from Monsignor Martin Clerc to Josephine (Law) May Haines, letters from members of the Clerc family concerning financial matters, condolence letters, legal documents, and bills and receipts. The legal documents suggest that Monsignor Martin Clerc owned or negotiated the purchase of Villa Maria. Bills and receipts indicate that Josephine (Law) May Haines paid his expenses. He died in May 1894; obituaries form part of the subject file.
