Introduction

Suzanne (Earle) Ogden-Jones Emmons Bartlett (1862-1954) was the mother of Caroline (Ogden-Jones) Peter (1894-1965), who married Armistead Peter 3rd (1896-1983) of Tudor Place. Suzanne (Earle) Ogden-Jones Emmons Bartlett was married three times, finally to Paul Wayland Bartlett (1865-1925), an eminent sculptor. The Suzanne (Earle) Ogden-Jones Emmons Bartlett papers include approximately six linear feet of correspondence, subject files, scrapbook materials, news clippings, financial documents, printed material. This includes correspondence with family, her daughter Caroline (Ogden-Jones) Peter, friends, and business correspondence concerning Paul Wayland Bartlett's sculpture and property that she owned. Only a few financial documents survive and inventories of the Bartlett house and studio in Washington, D.C. Another component is material saved from the estate of Samuel Franklin Emmons (1841-1911), her second husband. The bulk of her collection covers the years 1930-1950.

These papers were a part of the estate Armistead Peter placed under the auspices of the Carostead Foundation, Incorporated, in 1966; the name of the foundation was changed to Tudor Place Foundation, Incorporated, in 1987. Use and rights of the papers are controlled by the Foundation. The collection was processed and the register prepared by Anne Webb, the Foundation archivist. This document was reformatted by Emily Rusch and revised by Tudor Place archivist Wendy Kail in 2020.

Biographical Sketch

Suzanne (Earle) Ogden-Jones Emmons Bartlett (1862-1954) was born January 21, 1862, at The Hermitage in Elkton, Maryland, daughter of George Earle (1821-1899) and Mary (Chamberlain) Earle (1821-1906). She grew up in Georgetown, Washington, D.C., at the Earle's family home The Cedars at the corner of 35th and Reservoir Road, currently the site of the Duke Ellington School for the Arts. In 1890 she married Mahlon Ogden-Jones (1849-1900) of Chicago, whose first wife, Vera de Trofimoff Jones (1854-1888), had died. Suzanne (Earle) Ogden-Jones Emmons Bartlett helped raise Mahlon Ogden-Jones' three children, Alexander de Trofimoff Ogden-Jones (1878-1943), Marie de Trofimoff Ogden-Jones (1879-1963), and Vera de Trofimoff Ogden-Jones (1885-ND), from his earlier marriage. Suzanne (Earle) Ogden-Jones Emmons Bartlett and Mahlon Ogden-Jones had one child of their own, Caroline (Ogden-Jones) Peter (1894-1965), who married Armistead Peter 3rd (1896-1983) of Tudor Place. Mahlon Ogden Jones died in 1900.

On Augusst 19, 1903, Suzanne (Earle) Ogden-Jones Emmons Bartlett had married Dr. Samuel Franklin Emmons (1841-1911), a noted geologist. He was a fellow of the Geological Society of London, the American Institute of Mining Engineers, president of the Geological Society of America in 1903, and the first president of the Colorado Scientific Society in 1882. In 1892 he was elected to the National Academy of Sciences; he was also a member of the Academy of Arts and Sciences, the American Philosophical Society, and the Geological Society of Washington. He was the recipient of honorary degrees from Harvard University and Columbia University in 1909. Samuel Franklin Emmons had been married twice before: he married Welthea Anita Steeves (Dates Unknown) in 1877; his second marriage was to Sophia Dallas Markoe (Birth Date Unknown-1896) in 1891. Documents from these marriages were retained by Suzanne (Earle) Ogden-Jones Emmons Bartlett and are held in this collection.

Suzanne (Earle) Ogden-Jones Emmons Bartlett established residences in Dinard and Paris, France. There she developed her interest in art and became acquainted with artists of the period. There she met and married the sculptor Paul Wayland Bartlett (1865-1925) on April 29, 1913. They lived in France, but also commuted to New York City and Washington, D.C. Suzanne (Earle) Ogden-Jones Emmons Bartlett assisted Paul Wayland Bartlett with his work, and after his death in 1925 became his legal and artistic executor. She arranged exhibitions of his work, and had numerous pieces recast and sold to benefit a proposed memorial studio which was never built. She gave the bulk of his papers to the Library of Congress. She died April 26, 1954, in France and is buried in Montparnasse Cemetery alongside Paul Wayland Bartlett.
