#### Tudor Place Manuscript Collection Armistead Peter 3rd Papers MS-21

#### Introduction

Armistead Peter 3rd (1896-1963) was the last private owner of Tudor Place, which was listed on the National Register of Historic Places in 1960. In 1966 Armistead Peter 3rd established the Carostead Foundation, Incorporated, eventually renamed in 1987 Tudor Place Foundation, Incorporated, to preserve the house, its collections, and grounds. In 1966 he deeded a scenic easement to the United States Department of the Interior to protect the exterior and grounds of the property, the first scenic easement donated to the United States under the Historic Sites Act of 1935.

These papers were a part of the estate of Armistead Peter 3rd placed under the auspices of the Tudor Place Foundation. Use and rights of the papers are controlled by the Foundation. The collection was processed and the register prepared by Anne Webb, the Foundation archivist, and by James Kaser, a project archivist hired through a National Historical Records and Publications grant in 1992. In 2020 this document was reformatted by Emily Rusch and revised by Tudor Place archivist Wendy Kail.

#### Biographical Sketch

Armistead Peter 3rd (1896-1983) was born on July 9, 1896, in Jackson County, Cambridge, New York. He was the son of Armistead Peter, Jr., (1870-1960) and Anna (Williams) Peter (1872-1961). He attended the Misses Eastman School and The University School, in Washington, District of Columbia and graduated from Saint Albans National Cathedral School for Boys in 1915. In 1917 he enlisted in the Naval Reserve as a radio electrician third class, and was assigned to the radio station in Arlington, Virginia; he was next assigned to the control room of the Department of State. Six months later he passed the examination for Ensign and was transferred to Aircraft Section, Bureau of Steam Engineering, where he worked until the armistice was signed.

In 1921 he married Caroline Ogden-Jones (1894-1965); they lived in Paris, France, and their daughter Anne Custis Peter was born in 1922. He was encouraged by his wife's stepfather, the sculptor Paul Wayland Bartlett (1865-1925), to pursue his interest in art. He studied at the Académie Colarossi and the Grande Chaumiere in Paris and with Walter Griffin in Nice. When his parents separated in 1923, Armistead Peter 3rd returned to the United States to assume responsibility for family affairs. He divided his time between Tudor Place and Cambridge, New York, where he developed a poultry breeding farm. During World War II Armistead Peter 3rd again served in the United States Navy, first in the office of the Joint Chiefs of Staff and then in the Pacific. He left the Navy as a Lieutenant Commander in 1946.

While his father was in residence at Tudor Place, Armistead Peter 3rd confined his efforts to provide financial support for the upkeep of the house and improve the garden. After his father's death in 1960, however, he and Caroline (Ogden-Jones) Peter began to refurbish and update Tudor Place. His wife died in 1965 and Armistead Peter 3rd wrote a book, privately published in 1969, dedicated to her about the history and his memories of Tudor Place. During the 1960s and 1970s he was actively involved in Georgetown civic affairs, serving for three years as President of the Progressive Citizens Association of Georgetown, and joined efforts to prevent construction transportation projects to preserve the tranquility of Georgetown. He continued to draw and paint throughout his lifetime. In 1973 he married Helen (Tucker) Andrews Macondray (1900-1995). He died on December 9, 1983, leaving Tudor Place and its collections to the Foundation he had established.

#### Scope and Content

The Armistead Peter 3rd papers consist of approximately 100 linear feet of personal and business correspondence, subject files, literary productions, financial records, blueprints and architectural drawings, inventories, and scrap book material. The papers span the period from 1900 to 1983, with the heaviest concentration between 1940 and 1980.

The personal correspondence is mostly from family members including his parents, wife, and daughter. Business correspondence and financial records reveal family financial matters, management and renovation/preservation of Tudor Place, management of his farm in upstate New York, art shows, involvement in Georgetown civic affairs, and the establishment of his foundation to preserve Tudor Place for future generations. A large block of material concerns the writing, production, and distribution of his book <u>Tudor Place</u> published in 1969, which describes the house and grounds in detail and gives the history of its inhabitants. An accompanying book of architectural drawings was also published.

Subject files reflect Armistead Peter 3rd's childhood education, military service in both world wars, farming activities, travels, artistic endeavors, furnishing of Tudor Place, care for its garden, civic activities, and social life.

The papers also contain some financial records of his father, Armistead Peter, Jr., from the 1920s to 1960, when Armistead Peter, Jr., owned and resided at Tudor Place, but his son provided much of the financial support. This material was evidence in a legal dispute regarding the inheritance taxes on Tudor Place, and therefore became part of Armistead Peter 3rd's papers.
