Started in 1991 through Tudor Place Foundation and a grant by Marpat Foundation, Inc., the *Sound Recordings, Tudor Place Foundation Oral History Project* is a collection of 55 tapes from 40 different people from the years 1991-1994, and 2004 containing information about Tudor Place the house and the Peter Family.

Description

Oral histories for *Sound Recordings, Tudor Place Foundation Oral History Project* were recorded from 1991-1994. In 2004, another interview was conducted interviewing the grandchildren of Max Rosinski about his life. The interviews contain information regarding Tudor Place and the Peter Family, namely Armistead Peter III and his daughter Ann Custis Peter. Recordings also contain information about workers at the house such as Bruna Lancellotti, wife of the groundskeeper from the 1970s-1980s, security guard Julius Gordon, Dean Philpott architect for the garage addition and bomb shelter, and many others. There is also a recording by Arthur Romer who records the Board Meeting Notes from 1990. The other half of the recording details renovations and work done to Tudor Place over the years. Romer's tape appears to have had something previously recorded since side B also has contemporary music playing at the end.

Scope and Content

Sound Recordings, Tudor Place Foundation Oral History Project consists of 1 document box, 1 storage box, and 7 small storage boxes totaling 2 1/2 linear feet. The document and storage box contains documentation and transcripts pertaining to the start of the project and oral history interviews. The 7 small storage boxes contain cassette tapes and copy cassette tapes of the oral history interviews.
