THE PLAN WAS APPROVED BY THE BOARD OF TRUSTEES IN MARCH 2012 AND RECEIVED CONCEPT APPROVAL FROM THE OLD GEORGETOWN BOARD THAT SAME MONTH. A CAPITAL CAMPAIGN IS UNDERWAY TO FUND IMPLEMENTATION OF THE MASTER PRESERVATION PLAN. SINCE 2012, TUDOR PLACE HAS BEEN RAISING FUNDS FOR IMPLEMENTING PROJECTS OF ITS MASTER PRESERVATION PLAN. IN 2019, THE ORGANIZATION COMPLETED THE INSTALLATION OF A STORMWATER MANAGEMENT SYSTEM ON THE SOUTH LAWN AND SCHEMATIC DESIGN FOR THE RENOVATION AND EXPANSION OF THE GARAGE TO SERVE AS A COLLECTIONS MANAGEMENT CENTER. IN 2023, THE
