Introduction

George Augustine Haines (1843-1915) was the second husband of Josephine (Law) May Haines (1834-1899), the aunt of Anna (Williams) Peter (1873-1961), wife of Armistead Peter, Jr., (1870-1960). Although George Augustine Haines' papers contain some material related to his business activities in the United States, most of the material dates from after his marriage to Josephine (Law) May Haines in 1895 and his removal to Cadenabbia, Italy, to live at the Villa Maria on Lake Como. The papers include social and business correspondence, subject files, legal documents, financial documents, and scrapbook material. This material deals with Haines' investments, law suits, renovation and decoration of Villa Maria, and social life.

His papers came to Tudor Place through Armistead Peter, Jr., who was responsible for closing Villa Maria and disposing of the contents of the house after the death of George Augustine Haines. These papers were a part of the estate Armistead Peter placed under the auspices of the Carostead Foundation, Incorporated, in 1966; the name of the foundation was changed to Tudor Place Foundation, Incorporated, in 1987. Use and rights of the papers are controlled by the Foundation. The collection was processed and the register prepared by James Kaser, a project archivist hired through a National Historical Records and Publications grant in 1992. This document was reformatted by Emily Rusch and revised by Tudor Place archivist Wendy Kail in 2020.

Biographical Sketch

George Augustine Haines (1843-1915) was born August 2, 1843, to Augustine Haines (1810-1873) and Frances (Patten) Haines (1816-1894) of Portland, Maine. George Augustine Haines' father was a lawyer and an agent for the Laconia Company, Biddeford, Maine, which manufactured textiles. George Augustine Haines graduated from Bowdoin College, Brunswick, Maine, in 1863 and returned to his hometown Portland, Maine, to learn the textile business. From 1866-1868 he went to Europe and travelled to observe the European textile industry. Upon his return to the United States, he worked as a cotton merchant in Mobile, Alabama, and Boston, Massachusetts; he retired from business in 1890.

On September 16, 1895, he married Josephine (Law) May (1834-1899) of New York, daughter of George Law (1806-1881) and Sarah (Anderson) Law (1810-1883), and widow of Colonel Charles Augustus May (1818-1864). The couple resided at the Villa Maria on Lake Como, Cadenabbia, a community in Lombardy, Italy. Although he married Josephine (Law) May Haines late in life, her family welcomed him cordially; he visited her sisters Sarah (Law) Williams 1827-1912) and Anna (Law) Wright (1841-1917) at their farms in Cambridge, New York. By the time he died, all three of the Law sisters, Josephine (Law) May Haines, Sarah (Law) Williams, and Anna (Law) Wright were deceased; Anna (Williams) Peter (1873-1961), daughter of Sarah (Law) Williams, inherited the bulk of the George Augustine Haines estate; the papers of her husband, Armistead Peter, Jr. (1870-1960), hold additional information about the Villa Maria and the Haines estate. Josephine (Law) May Haines died at Basel, Switzerland, July 5, 1899. George Augustine Haines died at Cadenabbia, Italy, on January 5, 1915.

CORRESPONDENCE

1891-1914; ND

The general personal correspondence of George Augustine Haines primarily consists of incoming correspondence discussing travel and social events. Many of the letters extended gratitude for hospitality. Some letters are from women and appear to arrange assignations. There are significant numbers of letters from Haines family members and Anna (Law) Wright, Sarah (Law) Williams, and Alga (Smith) Law. Letters from financiers Dwight Braman and Norman Whitehouse are present. Also included are condolence letters upon the death of George Augustine Haines' mother Frances (Patten) Haines and congratulatory letters upon his engagement and marriage to Josephine (Law) May Haines. A large number of letters and telegrams during July and August of 1899 are letters of condolence upon the death of Josephine (Law) May Haines.

CORRESPONDENCE: EDWARD BAXTER FELTON

1895-1913, scattered

Incoming and outgoing

Edward Baxter Felton was a close friend before George Augustine Haines married Josephine (Law) May Haines. These letters reveal that Edward Baxter Felton was involved in the Delmont and Colburn matters (see subject files). The letters break into four segments: letters from 1894 and 1895 were written prior to and in the early days of the Haines' marriage and deal extensively with Delmont; letters from 1897 and 1899 deal with the Colburn case and Felton's financial difficulties; from 1900 to 1902 the Colburn matter is again an issue; from 1910 to 1913 Edward Baxter Felton is an executive of a mining firm and he advises about financial matters. Several outgoing letters in the series reveal George Augustine Haines' financial condition at various times.

CORRESPONDENCE: FRANCES (PATTEN) HAINES

1886-1893

Incoming

Letters from George Augustine Haines' mother discuss her health and concerns about expenses and investments, her activities and relate news of family members.

CORRESPONDENCE: JOSEPHINE (LAW) MAY HAINES

1893-1898; ND

Incoming

Primarily written after their marriage, these letters describe her relationship with George Augustine Haines and provide information about her activities and those of their friends.

CORRESPONDENCE: SUSAN LYMAN

1895-1898; ND

Incoming

Letters from Susan Lyman, an aunt of Haines who lived in Brookline, Massachusetts, discussing matters of her immediate household and Boston society.

CORRESPONDENCE: PETER FAMILY

1895-1914

Incoming

Includes letters from Armistead Peter, Jr., Anna (Williams) Peter, and Armistead Peter 3rd. The letters comment upon travel, social events, daily activities, and contain some news of other family members.

CORRESPONDENCE: JOSEPHINE POMEROY.

Ca.1904; ND

Incoming

Josephine Pomeroy was a close friend of Haines. Although her age cannot be determined, she appears to have been considerably younger than he was. She traveled by automobile accompanied by her chauffeur and maid. At one time she and George Augustine Haines were going to marry [see related subject file].

SECOND PARTY CORRESPONDENCE

1907-1913, scattered

Incoming

Includes letters to Alga (Smith) Law and John Ortelli

BUSINESS CORRESPONDENCE

1871-1914; ND

Incoming and outgoing

The correspondence includes letters dealing with brokerage houses, investment prospectuses, banks, and the decoration of Villa Maria. Also included are letters from law firms including Carter and Ledyard, letters of transmittal for bills/receipts and dividends, letters from wine merchants, couturiers, jewelers, poultry merchants, and transport companies. Some material covers George Augustine Haines' management of his mother's and wife's investments.

BUSINESS CORRESPONDENCE: JAMES AFFLECK

1896-1913

Incoming

Letters refer to the Eighth and Ninth Avenue Railroads, and are primarily responses to inquiries posed by George Augustine Haines about financial matters. Some letters relate to the death of Sarah (Law) Williams.

BUSINESS CORRESPONDENCE: AUGUSTO GUIDINI

1895-1901

Incoming

Letters from Milan architect A. Guidini concerning the renovation and decoration of Villa Maria. [See Josephine May Haines Papers.]

BUSINESS CORRESPONDENCE: CHARLES F. LIBBY

1895-1914

Incoming

Charles F. Libby was a lawyer in Portland, Maine, George Augustine Haines' hometown. These letters deal with matters related to the settlement of Haines' mother's estate and offered business advice.

BUSINESS CORRESPONDENCE: JAMES MCKEEN

1895-1901

Incoming

James McKeen was a New York lawyer who handled several legal and business matters for Haines.

BUSINESS CORRESPONDENCE: JOHN F.A. MERRILL

1895-1907

Incoming

John F.A. Merrill, a New York lawyer, was George Augustine Haines' attorney in the Lynch case, the Colburn case, the Baxter settlement, and the First National Bank of Portland case.

BUSINESS CORRESPONDENCE: GEORGE F. NOYES

1898-1905

Incoming

A Portland, Maine, lawyer, George F. Noyes, worked for George Augustine Haines' behalf in the settlement of his mother's estate and the final out of court settlement of the Colburn case.

BUSINESS CORRESPONDENCE: LUDOVICO PAGLIAGHI

1896-1914; ND

Incoming

Ludovico Pagliaghi was the contractor for the renovation of Villa Maria and subsequent improvement projects.

BUSINESS CORRESPONDENCE: JOHN M. SCRIBNER 1897

John M. Scribner was legal counsel in the settlement of the George Law, Sr.'s, and George Law, Jr.'s, estate.

BUSINESS CORRESPONDENCE: EDWARD LYMAN SHORT 1894-1910. scattered

Edward Lyman Short was general solicitor for the Mutual Life Insurance Company and acted on George Augustine Haines' behalf in the Sperry patent case. The Colburn case is discussed in some of the letters. He was also possibly a relative through the Lyman family and many of his letters include personal information.

BUSINESS CORRESPONDENCE: SAMUEL S. THOMAS 1899-1907

Samuel S. Thomas, a New York lawyer, represented George Augustine Haines in the Colburn case and the Bank of Portland case. Included as attachments are legal documents and second party correspondence.

BUSINESS CORRESPONDENCE: OUTGOING DRAFTS 1886-1914; ND

Drafts of outgoing correspondence on a variety of business matters, including the legal cases in which George Augustine Haines was involved.

SUBJECT FILES

Series

BANK OF PORTLAND CASE

1900-1903

Correspondence from Edward Short, Samuel Thomas, and John Merrill, as well as legal documents. [See Business Correspondence files of Edward Lyman Short, Samuel Thomas and John Merrill.]

BARON OPPENHEIM

1897-1899

Baron Oppenheim was apparently a Paris entrepreneur through whom George Augustine Haines invested money; these files include a number of business prospectuses.

COLBURN CASE

1896-1901; ND

Includes correspondence, notes, legal documents, and trial exhibits. Mary F. Colburn, a friend of George Augustine Haines, was persuaded by him to set up a joint investment account with a man named Delmont. Delmont was an illegitimate speculator and all of the money and securities in the joint account were lost. Colburn

subsequently initiated a legal case against George Augustine Haines to recover her losses. An out of court settlement was reached.

DELMONT PARTNERSHIP

1894-1897; ND

An extensive amount of correspondence from Delmont concerning the stock speculations in which the two men were involved. Also included are drafts of an agreement between the two men and receipts. [See the related material in the Subject File on the Colburn case and in the Business Correspondence files of George Augustine Haines' lawyers.]

FRANCES (PATTEN) HAINES ESTATE

1894-1904

Includes correspondence, legal documents, bills and receipts, and account statements concerning the settlement of the estate of Haines' mother and correspondence with Charles F. Libby, John F.A. Merrill, and George F. Noyes.

JOSEPHINE (LAW) MAY HAINES ESTATE

1899

Includes correspondence, the death certificate, and bills and receipts. There is a shipping receipt for the return of the body to the United States.

MONSIGNOR MARTIN CLERC

1898-1900

Correspondence and receipts concerning financial settlements made with the family of Josephine (Law) May Haines' chaplain after his death.

MONTEZUMA VALLEY WATER SUPPLY COMPANY

1886-1887

George Augustine Haines invested and apparently coordinated other people's investments in the Montezuma Valley Water Supply Company, a company organized to irrigate land in Colorado.

JOSEPHINE POMEROY

1904

Josephine Pomeroy and George Augustine Haines planned to marry. These files contain affidavits required of each of them to marry in France. One piece of correspondence is from George Baldwin Newell, the brother-in-law of Josephine Pomeroy.

PORTLAND STORE

1864; 1894

Augustine Haines, George Augustine Haines' father, owned a half interest in a Portland, Maine, store; the other half was owned by A. J. Libby. Upon Augustine Haines' death his share was transferred to Frances (Patten) Haines, his wife. Upon her death this share was transferred to her son, George Augustine Haines. This file contains the original purchase document.

REGISTRATION OF AMERICAN CITIZENSHIP

1915

Registration with the American Consul in Milan as an American citizen. George Augustine Haines had been in Europe since 1895.

SPERRY PARTNERSHIP

1899-1904

Elmer A. Sperry, a Cleveland electrical engineer, held a joint patent to a governor for marine engines with George Augustine Haines. George Augustine Haines was active in securing European patents on the device and promoting it. Possibly the joint patent was a form of payment to George Augustine Haines. [See Business Correspondence files containing letters of Edward Lyman Short.]

TIEPOLO PAINTING

1913

Materials relating to a painting, supposedly by Tiepolo, that George Augustine Haines purchased and displayed at the Villa Maria.

VENUS OF SYRACUSE

1910; ND

Correspondence, bills, and receipts for work done in creating a replica of the Venus of Syracuse.

VILLA MARIA

1893-1895

Includes correspondence, drawings, bills and receipts. These files constitute a detailed record of the construction and renovation at the Villa Maria at the time Josephine (Law) May Haines assumed ownership. The titles of the files are the original titles of the files found bundled together. Although some general headings were used, the titles stem from the name of the contractor/subcontractor, or the type of work, glazier, tile layer, etc., arranged alphabetically.

VILLA MARIA: RENOVATIONS

1897-1907

Correspondence, drawings, bills and receipts for renovation at the Villa Maria subsequent to the Haines' residence there. Most renovations focused on the construction of a dock and terraced steps down to Lake Como.

1906

Lengthy handwritten draft of a letter to the editor of the *New York Times* on the evils of trust busting.

DRAFTS

ND

Includes drafts of poems and a document praising J.P. Morgan.

NOTES

1898, 1912; ND

Includes a wide variety of notes, mostly fragmentary.

LEGAL DOCUMENTS

Series

LEGAL AGREEMENTS

1897; ND

Includes drafts of agreements, a power of attorney, and a collateral loan agreement.

LEGAL VERDICT

1899

A verdict in a case brought against Josephine (Law) May Haines in a Milanese court.

PROMISSORY NOTES

1879-1914

Promissory notes through which George Augustine Haines borrowed varying amounts of money. The largest notes are for forty and fifty thousand dollars; all of the notes are canceled to show payment.

SAFE CONDUCT PASS

1895

Issued by Wayne MacVeagh, United States Ambassador to Italy.

WARRANTY DEED

1897

Transferring property in Colorado from George Augustine Haines to Milton Cage.

WILL: DRAFTS

1900

Notes and complete draft of a will disposing of property in Portland, Maine, and \$21,000 dollars.

FINANCIAL DOCUMENTS

Series

LEDGERS

1894-1903; scattered

Ledgers for Villa Maria expenses primarily kept by the estate's manager.

ACCOUNT BOOKS

1898-1908

Books for accounts kept with an Italian grocer, pastry shop and dairy, as well as with banks.

ACCOUNT STATEMENTS

1897-1914

Bank and brokerage house account statements, arranged alphabetically by institution and then chronologically. Includes accounts with Brown and Shipley, Dwight Braman, Hopkins Brothers, Knickerbocker Trust Company, J.P. Morgan, Morgan and Harjes, Taylor and Livingstone, United States Trust Company, and Whitehouse and Company.

CHECKBOOKS

1894-1916

Checkbooks, mostly from Italian banks, arranged alphabetically by institution and then chronologically. Includes checkbooks for accounts from Banca di Lecco, Banco Lariano, Brown and Shipley, Knickerbocker Trust Company, Merchants National Bank, J.P. Morgan, Morgan and Harjes, and National Hide and Leather Bank.

CANCELED CHECKS

1887-1913

Checks drawn upon accounts with Brown and Shipley, Knickerbocker Trust, and J.P. Morgan, arranged alphabetically by institution and then chronologically.

BILLS AND RECEIPTS

1886-1914

Arranged chronologically

Includes bills and receipts, mostly from Italian businesses.

STOCK CERTIFICATE

1890

Certificate for five-hundred-fifty shares of the Colorado Consolidated Land and Water Company.

INVENTORIES

1896, 1898, 1913; ND

Inventories of household linen, silver, stocks and bonds, and furniture.

FINANCIAL NOTES

1896: ND

Notes on shares of stocks and miscellaneous fragmentary notes. Also includes an analysis of Josephine's indebtedness in 1895-1896: a total of \$123,440 owed to florists, jewelers, and interior decorators; and an undated analysis of George Augustine Haines's stock holdings with the United States Trust Company for \$262,700.

Pencil and ink drawings of people and George Augustine Haines' dog. Cartoons reveal George Augustine Haines' sense of humor.

ARCHITECTURAL RENDERINGS/MEASUREMENTS: VILLA MARIA

ND

Includes measurements of rooms, architectural details, floor plans, and plans for a greenhouse.

RECORD OF CHESS MOVES

ND

Notebook of chess moves.

1891-1900; ND

Primarily contains newspaper clippings of letters to the editor written by George Augustine Haines.

1888-1912, ND

Handwritten and typewritten copies of poems. A number of the poems are tributes to George Augustine Haines, Josephine (Law) May Haines, or Villa Maria.
