CONSERVATION OF BUILDINGS AND GROUNDS - LOCATED ON FIVE AND A HALF ACRES OF LAND IN WASHINGTON'S GEORGETOWN NEIGHBORHOOD, TUDOR PLACE MAINTAINS SEVEN HISTORIC STRUCTURES, INCLUDING A NATIONAL HISTORIC LANDMARK HOUSE DESIGNED BY DR. WILLIAM THORNTON, ARCHITECT OF THE FIRST UNITED STATES CAPITOL, AND COMPLETED IN 1816. THE SURROUNDING GARDENS RECORD THE EVOLUTION OF THE PROPERTY FROM 1805-1983. TUDOR PLACE COMPLETED AN ARCHITECTURAL ANALYSIS ON THE LANDMARK HOUSE IN 2004, A CONSERVATION ASSESSMENT OF THE STRUCTURE IN 2005, AND A CULTURAL LANDSCAPE REPORT IN 2012.
